6. PUBLIC HEARINGS

6.a. Public Hearing (Published Notice) to Introduce Ordinances Amending Title 15 of the Municipal Code to Incorporate 2019 Editions of California Building Codes with Local Amendments

Economic and Community Development Director Carmela Campbell presented the staff report. There were no additional questions or comments from Council.

Mayor Dutra-Vernaci opened the public hearing and called for public comment. Being none, Mayor Dutra-Vernaci closed the public hearing.

It was moved by Councilmember Duncan and seconded by Councilmember Patiño to Introduce the twelve (12) ordinances, Attachments 1 -12 of the staff report, that update Title 15 consistent with the updated 2019 State California Building Standards Codes and local amendments, waive formal reading of the ordinances, and schedule a public hearing regarding adoption of the 2019 Edition of the Codes, for November 12, 2019. The motion was carried by a unanimous voice vote.

7.a. Adopt a Resolution Approving a New Vision, Mission, and Values and City Council Priorities and Authorizing the Implementation of the 2020-2025 Strategic Plan

City Manager Joan Malloy presented the staff report, detailing the Strategic Plan process and the new Vision, Mission, and Values statements and Council priorities. City Manager Malloy responded to questions from Council. Councilmembers provided comment.

Public comment was given by Roland Villena.

It was moved by Councilmember Gacoscos and seconded by Vice Mayor Singh to adopt **Resolution No. 5530-19** Approving a New Vision, Mission, and Values and City Council Priorities and Authorizing the Implementation of the 2020-2025 Strategic Plan. The motion was carried by a unanimous voice vote.

7.b. Adopt a Resolution of the City Council of the City of Union City Approving and Adopting a Memorandum of Understanding between the City of Union City and Professional Employees Group, Authorizing the City Manager to Execute the Memorandum of Understanding and Approving an Amendment to the City's Salary Schedule in Conformance with California Code of Regulations, Title 2, Section 570.5

Finance Director Mark Carlson presented the staff report, providing detail on the major components of the MOU and the fiscal impact of the threeyear contract.

It was moved by Vice Mayor Singh and seconded by Councilmember Patiño to adopt **Resolution No. 5531-19** Approving and Adopting a Memorandum of Understanding between the City of Union City and Professional Employees Group, Authorizing the City Manager to Execute the Memorandum of Understanding and Approving an Amendment to the City's Salary Schedule in Conformance with California Code of Regulations, Title 2, Section 570.5. The motion was carried by a unanimous voice vote.

7.c. Adopt a Resolution Updating the Authorized Position List and Salary Schedule to Reflect Changes in Positions

Director Carlson presented the staff report, providing detail on the updates to the positions list and their fiscal impact. Director Carlson responded to questions from Council. Councilmembers provided comment.

It was moved by Vice Mayor Singh and seconded by Councilmember Duncan to adopt **Resolution No. 5532-19** Updating the Authorized Position List and Salary Schedule to Reflect Changes in Positions. The motion was carried by a unanimous voice vote.

7.d. Adopt a Resolution of the City of Union City Authorizing Application for, and Receipt of, SB 2 Planning Grant Program Funds

Director Campbell presented the staff report, providing detail on grant requirements that have been met by the City, and the City's intended use for the approximate \$310,000 grant funds. There were no questions or comments from Council.

It was moved by Councilmember Patiño and seconded by Councilmember Gacoscos to adopt **Resolution No. 5533-19** Authorizing Application for, and Receipt of, SB 2 Planning Grant Program Funds

7.e. Adopt a Resolution Authorizing the City Manager to Proceed with Implementing a Closure Plan for Fire Station 30

City Manager Malloy presented the staff report, providing detail on the steps taken thus far and the actions still needed to be completed prior to closing Station 30, anticipated for January 2020.

Mayor Dutra-Vernaci announced that ACTC will host public meeting at the Kennedy Youth Center on Tuesday, October 29 regarding the East 14th Street and Mission Boulevard corridor improvements plan.

Mayor Dutra-Vernaci noted a MTC meeting on the I-880 Express Lanes on a date yet to be determined in early December.

City Manager Malloy provided an update regarding the PSPS, stating the shutoff was anticipated to begin at noon, October 9 and could extend through the weekend. City Manager Malloy detailed the City's action plan during the power outage and encouraged people to check their specific addresses for potential impact at pge.com.

Mayor Dutra-Vernaci added that the outages will not affect the entire City and offered additional preparation tips.
