The urbanized area of the community is generally limited to approximately nine square miles of flatlands between the hillsides and the baylands. Because of these constraints, Union City cannot annex new areas to expand its borders. Development of the few remaining vacant sites and the redevelopment of underutilized sites are the only options to accommodate future growth.”*

This planned roadway was historically known as State Route 84 and the East-West Connector and has been a priority for the City Council since it was envisioned in 1986.”*

*“This roadway will alleviate traffic on Decoto Road and provide a much needed secondary access point for cars, trucks, emergency vehicles, bicycles, and pedestrians.”*
- Updated first sentence of last paragraph of page 158 to include:
 

*“...and the extension of Dyer Street under Interstate 880 along a railroad right-of-way to link Union City’s freeway commercial centers.”*
- Modified Policy M-2.19 (p. 166) to read:
 

*“The City shall maintain its Bicycle and Pedestrian Citizens Advisory Committee (BPAC) composed of five members, including one representative each from the Planning Commission and Parks and Recreation Commission, two residents from the community at large, and a representative (either resident or non-resident) from the bicycling community. The BPAC shall meet on an as needed basis to provide feedback on updates to the City’s Pedestrian and Bike Master Plan and specific bicycle and pedestrian projects within the City.”*

*“An at-grade pedestrian crossing of the adjacent railroad track (Oakland Subdivision) that will facilitate the east-west connections for pedestrians and provide direct access to BART.”*

*“The proposed Quarry Lakes Parkway is a planned multimodal transportation corridor that extends between Mission Boulevard (SR 238) in Union City and the I-880/Decoto Road Interchange in Fremont. The portion of Quarry Lakes Parkway in Union City includes a four-lane corridor with Class II bike lanes, landscaped medians and green infrastructure and a separated Class I bicycle highway connecting regional parks, trails,*

*neighborhoods, schools and public transit (BART, AC Transit, Dumbarton Express and Union City Transit). The parkway will provide secondary access to the Union City BART Station and the Greater Station District with direct connections at 11th Street and 7th Street. The parkway is designed with grade separations at BART and two railroad lines, which will facilitate emergency access in and around the Greater Station District. This Quarry Lakes Parkway project is part of the County Wide Transportation Plan.”*

- Revised Policy M-6.1 (p. 182) to read:

*“The City shall continue to implement variable parking standards that reflect expected level of parking demand based on such factors as land use, proximity to transit, type of occupancy (e.g., seniors, multigenerational families), and intensity. Parking standards should reflect the City’s goal of reducing vehicle miles traveled.”*

- Revised Policy M-6.2 (p. 182) to read:

*“The City shall ensure that there is adequate off-street parking within new developments to avoid an overflow of parking on the street to the extent feasible.”*

- Deleted an incorrect segment on Figure M-7.1 (p. 185).

- Deleted extraneous information from the first paragraph of the Fire Protection section (p. 251).
- Modified Policy PF-10.1 (p. 251) to read:

*“The City shall review and refine the agreement with ACFD, as needed. Levels of service provided under the contract, may be subject to budgetary limitations.”*

- Updated number of private schools from five to four under the Schools section (p. 253).
- Updated the year the Union City branch of the Alameda County Library was constructed from 1965 to 1976 under the Library section (p. 255).

***“RC-3.2: Work with ACWD to Protect and Recharge Aquifers.*** *The City shall work with the Alameda County Water District to protect and recharge the Niles Cone water-bearing aquifers through a variety of measures including the incorporation of green infrastructure elements into new development projects.”*

- Updated Policy RC-3.4 to include hydro-modification in list of stormwater management practices listed at the end of the policy. (p. 271)

- Updated Policy RC-3.5 (p. 271) to read:

*“The City shall incorporate low-impact development measures using green streets infrastructure as identified in the Green Infrastructure Plan, such as rain gardens, infiltration planters, tree wells, and permeable paving to improve the quality of stormwater runoff within City projects and within existing roadways to the extent feasible.*

- Modified Goal RC-4 (p. 272) to read:

*“To protect, to the extent possible, the City’s significant archeological and historical resources.”*

- Modified the first sentence of the last paragraph of the Energy Conservation section (p. 276) to read:

*“This section focuses on programs and initiatives that promote energy conservation in the built environment.”*

- Added new policy (p. 275):

***“RC-5.4: Health Risk Assessments.*** *The City shall implement Bay Area Air Quality Management District (BAAQMD) CEQA Guidelines and State Office of Environmental Health Hazard Assessment policies and procedures requiring health risk assessments (HRAs) for new residential development and other sensitive receptors, as defined in the BAAQMD CEQA Guidelines, within 1,000 feet of sources of toxic air contaminants, including freeways and roadways with over 10,000 vehicle trips per day. Based on the results of the HRA, the City shall identify and implement measures, such as air filtration systems, to reduce potential exposure to particulate*

*matter, carbon monoxide, diesel fumes, and other potential health hazards. Measures identified in HRAs shall be included into the site development plan as a component of a proposed project.”*

- Modified Policy RC-7.1 (p. 279) to read:

*“Establish Greenhouse Gas Reduction Targets. The City shall establish community and municipal greenhouse gas emission reduction targets in the Climate Action Plan that are consistent with the State Scoping Plan, AB 32, and SB 32.”*

- Updated time frame for Implementation Program RC-6.A to FY 22/23 (p. 280).

## **Additional Policies to Mitigate Potential Significant Impacts (to be included in final document)**

- **Measure BIO-1: Nesting Bird Protection Policy.** The following policy shall be added to the 2040 General Plan Resource Conservation Element as Policy RC-2.10:

*“The City shall require project applicants to retain the services of a qualified biologist(s) to conduct a pre-construction nesting bird survey during the nesting season (February 1 through August 31) prior to all new development that may remove any trees or vegetation that may provide suitable nesting habitat for migratory birds or other special-status bird species. If nests are found the qualified biologist(s) shall identify appropriate avoidance measures, and these measures shall be incorporated into the project and implemented accordingly.” (p. ES-6, Final Environmental Impact Report)*

- **Measure CR-1: Cultural Resources Study Implementation Program.** The following implementation program shall be added to Resource Conservation Element of the 2040 General Plan:

*“If a project requires activities that have the potential to impact cultural resources, the City shall require the applicant to retain a qualified archaeologist meeting the Secretary of the Interior’s (SOI) Professional Qualification Standards (PQS) in archaeology and/or an architectural historian meeting the SOI PQS standards in architectural history to complete a Phase 1 cultural resources inventory of the project site (NPS 1983). A Phase 1 cultural resources inventory should include a pedestrian survey of the project site and sufficient background archival research and field sampling to determine whether subsurface prehistoric or historic remains may be present. Archival research should include a records search conducted at the Northwest Information Center (NWIC) and a Sacred Lands File (SLF) search conducted with the Native American Heritage Commission (NAHC). The technical report documenting the Phase 1 cultural resources inventory shall include recommendations to avoid or reduce impacts to cultural resources. These recommendations shall be implemented and incorporated in the project.” (p. ES-6, Final Environmental Impact Report)*



- **Measure GEO-1: Protection of Paleontological Resources.** The following policy shall be added to the Resource Conservation Element of the 2040 Union City General Plan:

*“Require avoidance and/or mitigation for potential impacts to paleontological resources for any development in Union City that occurs within high sensitivity geologic units, whether they are mapped at the surface or occur at the subsurface. High sensitivity geology units include Great Valley Sequence (Panoche and Knoxville Formations), Monterey Group (Claremont Shale and Hambre Sandstone), Briones Formation, Orinda Formation, and Pleistocene age alluvial fan and fluvial deposits. When paleontological resources are uncovered during site excavation, grading, or construction activities, work on the site will be suspended until the significance of the fossils can be determined by a qualified paleontologist. If significant resources are determined to exist, the paleontologist shall make recommendations for protection or recovery of the resource.”*

*“The City shall require the following specific requirements for projects that could disturb geologic units with high paleontological sensitivity:*

*Retain a Qualified Paleontologist to Prepare a PMMP. Prior to initial ground disturbance in previously undisturbed strata of geologic units with high sensitivity, as shown on Figure 4.6-3, the project applicant shall retain a Qualified Paleontologist, as defined by the SVP (2010), to direct all mitigation measures related to paleontological resources and design a Paleontological Mitigation and Monitoring Program (PMMP) for the project. The PMMP should include measures for a preconstruction survey, a training program for construction personnel, paleontological monitoring, fossil salvage, curation, and final reporting, as applicable.” (p. ES-8, Final Environmental Impact Report)*

## Special Areas Element

- Added the following sentence in the Core Station District section (p. 290):

*“Over time, the core mixed use commercial designation was expanded to include the BRE Apartments that are located south-westerly of Union Square.”*

- Modified second to last sentence of first paragraph in the Station East section (p. 297) to read:

*“The DIPSA Specific Plan recognized the importance of this area as a job center and it remains as one of the last opportunity areas for job creation near BART.”*

- Deleted last sentence of third paragraph of Station East section (p. 297); specifics of corridor design will be specified in a DIPSA Specific Plan update.

- Revised Figure SA-4.2 to show EDA Grant Job Lands (p. 299).

- Modified third to last sentence in first paragraph of the Union City Boulevard District (p. 311) to read:

*“Currently (2019), there is a need for safer and more inviting pedestrian and bicycle facilities.”*

- Modified language in the Mission Boulevard Corridor from “poorly maintained,” to “older” (p. 3222).
- Revised second half of the first paragraph of the Decoto Neighborhood section (p. 325) to read:

*“They later sold the land to the Decoto Land Company to lay out the settlement of Decoto in the area bounded by Whipple Road to the north, Mission Boulevard and Decoto Road to the east, and the rail lines to the south and west. With the construction of a train station and a grid of streets that ran parallel and at right angles to the rail lines.”*

- Updated Figures SA-11.1 (p. 328) and SA-11.2 (p. 331) to correct the Historic Alvarado District boundary line.

- Modified Policy SA-11.14 (p. 332) to read:

*“The City shall support businesses in the Historic Alvarado District and efforts to form and sustain a merchant’s association.”*

- Updated time frame for Implementation Program SA-1.E to FY 19/20 through 20/21 (p. 345).
- Updated time frame for Implementation Program SA-3.A to FY 22/23 (p. 345).

**SUBJECT:** DESK ITEM - DRAFT 2040 GENERAL PLAN

Commissioner Lew provided some comment / questions regarding the draft 2040 General Plan. City staff has provided responses to certain comments. The remaining comments, which mainly concern grammar and writing style, will be incorporated into the final document. Finally, the glossary was inadvertently left out of the draft General Plan document and will be included in the final document. All comments, including any public comments, will be brought back to the Planning Commission for final consideration.

1. Pg. 1, 3rd para. – I recommend deleting “In 2018,” in the first sentence and the comma after the word “strengths” in the last sentence.  
*Comment will be incorporated in final document.*
2. Pg. 1, notes 1 and 2 under the graph titled “Racial and Ethnic Make-up of Union City Residents” – it is unclear what these notes refer to. Are they footnotes? If so, I did not see any corresponding superior or raised number. Please clarify.  
*Footnote numbers will be added to the text in the final document. Footnote 1 refers to, “Union City is home to a diverse population of nearly 73,000 people.” Footnote 2 refers to, “Over 45 percent of residents in the city were born outside the United States.”*
3. Pg. 2, 1st para., last sentence – I recommend deleting the word “also” after “General Plan.”  
*Comment will be incorporated in final document.*
4. Pg. 2, 2nd para., 2nd sentence – I recommend deleting the word “also” after “the City is.”  
*Comment will be incorporated in final document.*
5. Pg. 3, 1st para., 2nd sentence – I recommend revising the sentence to read “This includes wetlands at the bay shoreline to the west and the vast open space hillside lands to the east.”  
*Comment will be incorporated in final document.*
6. Pg. 7, 2nd para., last sentence – the Intermodal Station does not currently serve ACE, Capital Corridor, and Dumbarton Rail as stated therein so this sentence should be corrected to provide

accurate information. For example, whether there are future plan to serve them.

*Final document will be revised to indicate that these lines may serve Union City in the future.*

7. Pg. 7, 5th para., last sentence – I recommend revising the sentence to read “These characteristics, which brought residents to Union City, are evident today and expected to remain so in the future.”  
*Comment will be incorporated in final document.*
8. Pg. 8, 2nd para., 2nd sentence – programs do not “create” students, etc. I recommend deleting “create” and inserting “result in.”  
*Comment will be incorporated in final document.*
9. Pg. 16, 3rd para., 2nd sentence – I recommend revising the sentence to read “The City recognized that many members of the community would be unable to attend community workshops and public meetings.”  
*Comment will be incorporated in final document.*
10. Pg. 18, 4th para., 2nd sentence – I recommend revising the sentence to read “Published in May 2015, it provides a ‘snapshot’ of Union City’s current conditions across a wide array of topics and a context for making land use and policy decisions because it is objective and policy-neutral.”  
*Comment will be incorporated in final document.*
11. Pg. 19, 1st para., 1st sentence – I recommend deleting the word “need.”  
*Comment will be incorporated in final document.*
12. Pg. 22, Table 1-1 – there are no blue dots in the column for “Open Space.” Please explain why this general plan element, which is indicated as required by state law, was excluded from this plan.  
*This was a typographic error. Open space policies are addressed in the Resource Conservation Element. A blue dot will be added to indicate this in the final document.*
13. Pg. 23, paragraph titled “Health and Quality of Life Elements”, 7th line – please correct the spelling of “traditionally.”  
*Comment will be incorporated in final document.*
14. Pg. 30, 1st para., last sentence – I recommend revising the sentence to read “A strong economic base provides the revenues needed to deliver essential city services and, in addition, quality of life services that make the community a desirable place to live and work.”  
*Comment will be incorporated in final document.*
15. Pg. 58, 5th para. – the 4th sentence refers to a range from 3 to 5 acres per 1,000 residents under state law. However, the 6th sentence, which refers to consistency with state law, states the City adopted the “maximum allowed standard of 3.0 acres....” This is inconsistent with State law which allows a maximum of 5.0 acres per 1,000 residents. Please clarify the 6th sentence.

*The maximum allowed standard of 3.0 acres per 1,000 residents is correct. Jurisdictions that have less than 3.0 acres of existing parkland per 1,000 residents are limited to adopting a maximum standard of 3.0 acres per 1,000 residents. This applies to Union City because the city's current ratio is 1.8 acres of parkland per 1,000 residents. The maximum allowed standard of 5.0 acres per 1,000 residents applies only to jurisdictions that have an existing ratio that meets or exceeds 5.0 acres of parkland per 1,000 residents. This is an explanatory response; no changes were made to the document.*

16. Pg. 60, 1st para. in right column – please correct the word “abroad” to “a broad.”  
*Comment will be incorporated in final document.*
17. Pg. 62, HQL-2.17, 5TH line – I recommend deleting the comma after “existing trails.”  
*Comment will be incorporated in final document.*
18. Pg. 63, 1st para., 4th sentence – the locations of the day camp facilities are confusing because there is a semicolon after “Old Alvarado/Cesar Chavez Park” which seems to set the first three locations apart from the next two locations. All locations should be listed with commas separating them. I recommend removing the word “and” before “Old Alvarado/Cesar Chavez Park” and changing the semicolon to a comma. Also, I did not see the Decoto Resource Center listed as a location for day camps in the Summer 2019 Activity Guide. Please verify this location provides day camp services.  
*Text edits will be incorporated in final document. Decoto Resource Center will be removed from the list of youth day camp sites, as it currently provides youth and family services but not recreation, arts, and cultural programs.*
19. Pg. 63, 1st para., last sentence – I recommend removing the colon after the word “including” or removing the word “including” and placing the colon after the word “abilities.” Using a colon after a word such as “including” is redundant and inappropriate. The only exception is when the items in the series are listed on separate lines.  
*Comment will be incorporated in final document.*

153. Pg. 343, SA-1.B, Item c – I recommend the item be revised to read “Improved lighting, sidewalks and pedestrian amenities throughout the Greater Station District, especially along Decoto Road and 7th Street, and within any new developments.”

154. Pg. 344, text box, last sentence – the statement that the DIPSA boundary encompasses the entire Greater Station District appears to be inaccurate if you compare Figure SA-IP.1 to Figure SA-1.1 on page 284. Please note the DIPSA boundary differs in each figure. Please correct this discrepancy.  
*Will revise to say, “The DIPSA boundary falls entirely within the Greater Station District.”*
155. Pg. 369, S-2.D – I recommend deleting the comma after “modernization.”

156. Pg. 376, RC-6.A, 3rd sentence – I recommend removing the comma after “(i.e., tankless).”

157. Any changes to Implementation Programs for the nine elements should also be changed in Chapter 10 for accuracy and consistency.
