RESOLUTION OF THE CITY OF UNION CITY AUTHORIZING THE CITY MANAGER TO SIGN TASK ORDER NO. 3 FOR RIDE-ON TRI-CITY! PARATRANSIT RELATED PROGRAM SERVICES FOR FISCAL YEAR 2019-2020, PURSUANT TO THE UNION CITY/FREMONT PARATRANSIT JOINT POWERS AUTHORITY AGREEMENT

WHEREAS, in 2017 the cities of Fremont and Union City executed a Joint Powers Agreement for paratransit related services, including Ride-On Tri-City!;

WHEREAS, the Ride-On Tri-City! paratransit related program services provides valuable same-day transportation service within the Tri-Cities for Union City residents who are eligible to use ADA (Americans with Disabilities Act) Paratransit service and/or are at least 80 years old; and

WHEREAS, the Ride-On Tri-City! paratransit related program services is currently administered by the City of Fremont and is available to eligible residents in Fremont, Newark and Union City; and

WHEREAS, the Ride-On Tri-City! paratransit related program services has previously been funded with Alameda County Transportation Commission administered Measure B Gap Grant funds and did not require a financial contribution from Union City; and

WHEREAS, beginning in Fiscal Year 2017-2018, the Tri-City Taxi Voucher Program was no longer be funded with Measure B Gap Grants; and

WHEREAS, the Cities of Fremont and Newark will continue to be using portions of their Direct Local Distribution Measures B and BB Transportation Sales Tax allocations to fund the Ride-On Tri-City! paratransit related program services for their respective residents in Fiscal Year 2019-2020; and

WHEREAS, the City of Union City wishes to continue to provide eligible Union City residents with access to the Ride-On Tri-City! paratransit related program services by using a portion of its Direct Local Distribution Measures B and BB Transportation Sales Tax allocations in Fiscal Year 2019-2020; and

WHEREAS, the City of Fremont will continue to provide program administration of the Ride-On Tri-City! paratransit related program services for the City of Union City through a Joint Powers Agreement; and

WHEREAS, the Joint Powers Agreement allows the City of Fremont to perform services in accordance with Task Orders issued to Union City; and

WHEREAS, Union City will request Ride-On Tri-City! paratransit related program services for Fiscal Year 2019-2020 through Task Order No. 3; and

WHEREAS, Union City has budgeted \$49,860 in Direct Local Distribution funds from Measures B and BB to fund Task Order No. 3; and

WHEREAS, each subsequent year that Union City desires to continue with the Ride-On Tri-City! paratransit related program services will be enacted through a new Task Order;

NOW, THEREFORE, BE IT RESOLVED that the City Manager is authorized to enter into a Joint Powers Agreement between the City of Fremont and the City of Union City and to sign Task Order No. 3 for the provision of Ride-On Tri-City! paratransit related program services for Fiscal Year 2019-2020.
