RESOLUTION OF THE CITY OF UNION CITY AUTHORIZING THE CITY MANAGER TO SIGN A JOINT POWERS AGREEMENT WITH THE CITY OF FREMONT FOR HUMAN SERVICES AND FAMILY RELATED RESOURCES AND TO EXECUTE A TASK ORDER FOR YOUTH DIVERSION AND SUPPORT SERVICES

WHEREAS, the City is authorized to enter into agreements with other cities for the performance of certain services; and

WHEREAS, Youth and Family Services ("YFS") provides youth violence prevention and intervention services to those in need in the Union City, Fremont, and Newark; and

WHEREAS, the City of Fremont has experience in performing certain specified services that will support and enhance the services offered by YFS; and

WHEREAS, the City has previously entered into a Joint Powers Agreement with the City of Fremont regarding transit services, and that relationship is ongoing; and

WHEREAS, the Joint Powers Agreement between the City of Fremont and the City of Union City, attached to this resolution as Exhibit A (the "JPA Agreement"), authorizes the City of Fremont to perform services in accordance with individual Task Orders issued by Union City; and

WHEREAS, the City of Union City desires to work with the City of Fremont to provide diversion services to 30 youth and life-skills and support services to 40 youth; and

WHEREAS, the City of Fremont will provide diversion services to the target population that are specifically structured to prevent formal entry into the juvenile justice system; and

WHEREAS, the City of Fremont will work collaboratively with YFS, the Alameda County Probation Department, the police department, local school districts, and other community service providers with the goal of providing alternatives to suspension and/or in-custody holds, coordinating diversion services, addressing barriers to program participation and supporting youth and their families through the Positive Youth Development framework in achieving their goals; and

WHEREAS, the City of Fremont will also provide life skills and support services and programs to enhance a youth's ability to live independently and provide skills and opportunities that are critical to success, such as tangible life skill development, and prosocial engagement; and

WHEREAS, the City of Fremont will provide the diversion and life skills programs through Task Order No. 1 to the JPA Agreement for the 2019-2020 fiscal year; and

WHEREAS, each subsequent year that Union City desires to continue with the diversion and life skills programs will be enacted through a new Task Order; and

WHEREAS, Union City and Fremont may arrange for the provision of additional services by Fremont for Union City by the mutual execution of subsequent individual Task Orders, which shall be subject to the terms and conditions set forth in the Joint Powers Agreement.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Union City herby declares as follows:

- 1. The above recitals are true and correct, and are incorporated into this resolution as though stated herein.
- 2. The City Manager is authorized and directed to enter into the Joint Powers Agreement between the City of Fremont and the City of Union City and to execute Task Order No. 1 for the provision of diversion and life skills programs for Fiscal Year 2019-2020 in an amount not to exceed Twenty Three Thousand One Hundred Fifty Seven Dollars (\$23,157), in such forms as approved by the City Attorney.
- 3. The City Manager is authorized and directed to take such other action and execute such documents as are necessary to carry out the purpose and intent of this resolution.
