Mayor Dutra-Vernaci called the meeting to order at 7:04 p.m.

6. PUBLIC HEARINGS

6.a. Conduct a Public Hearing and Adopt a Resolution of the City Council of the City of Union City Calling an Election to be Held on March 3, 2020, for Voter Consideration of the Extension of an Existing Voter-Approved Local Public Safety Services Tax Ordinance for Eight Years for the Continued Maintenance of Public Safety Services; Establishing Policies and Procedures in Connection with Such an Election; Requesting the Board of Supervisors of the County of Alameda to Consolidate the Special Municipal Election with the Presidential Primary Election to Be Held on March 3, 2020; Requesting Certain Services of the Registrar of Voters of Alameda County with Respect to the Special Municipal Election; and Providing for Submittal of Ballot Arguments and Rebuttals and Authorizing the Filing of An Impartial Analysis

City Attorney Kokotaylo, City Manager Malloy and Communications and Marketing Manager Sugayan presented the staff report, providing detail on the process taken thus far for the placement of an extension measure for the public safety parcel tax. Staff also provided detail on the negative financial impacts to public safety and the youth and family services should the public safety parcel tax not be renewed.

October 22, 2019, City Council received a report seeking direction regarding the terms of a potential successor measure and provided direction to return with a resolution placing a successor measure for the March 2020 election with the following terms:

Eight-year extension

Rate of \$175 per year for the most common residential parcel (with other rates adjusted by the same factor)

Annual inflationary adjustments at 3% or CPI, whichever is higher

Mayor Dutra-Vernaci opened the public hearing.

Mayor Dutra-Vernaci closed the public hearing.

Staff responded to questions from Councilmembers. Councilmembers provided comment.

Councilmembers Gacoscos and Patiño, and Vice Mayor Singh expressed their support for extending the public safety parcel tax, but at base tax rate of \$168.00 for most common residential parcel. The Councilmembers stated the amount \$168.00 was a good compromise and a rate they can support in seeking the extension.

Councilmember Patiño and Vice Mayor Singh also expressed support for an annual inflationary adjustments at a flat 3%.

Councilmember Duncan expressed her support for the previously directed tax rate of \$175.00 for the most common residential parcel. She stated there were many areas to compromise, but in her opinion, public safety was not the area for compromise. However, Councilmember Duncan stated she will support the measure irrespective of the rate decided upon by the majority of Council.

Mayor Dutra-Vernaci responded to some of the statements made during public comment and expressed support for extending the public safety parcel tax under the terms previously directed on October 22. However, Mayor Dutra-Vernaci stated she will support the measure irrespective of the rate decided upon by the majority of Council.

It was moved by Councilmember Duncan and seconded by Mayor Dutra-Vernaci to adopt a resolution Calling an Election to be Held on March 3, 2020, for Voter Consideration of the Extension of an Existing Voter-Approved Local Public Safety Services Tax Ordinance for Eight Years for the Continued Maintenance of Public Safety Services at the rate of \$175.00 for most common residential parcel and an annual inflationary adjustments at 3% or CPI, whichever is higher. The motion failed by the following vote:

the rate of \$168.00 for most common residential parcel and an annual inflationary adjustments at 3% or CPI, whichever is higher. The motion was approved by the following vote:
