Thank you for your response to my email. Our invitation and request to meet with you, your staff, and the city council still stands. I encourage you and the city administration to take us up on this offer so we may better understand each other's positions. It is our goal to voice our understanding of this matter. Educate us and allow us to do the same!

Per your email, (paragraph 2), we would like the opportunity to participate in the discussions for any actions relating to all fireworks, legal or illegal, planning, and/or otherwise.

I understand your statement about charging the organizations for the full cost of processing fireworks events. (paragraph 3)

I believe there may be a disagreement in stating the true costs as stated in your presentations. It is my opinion that there are key categories that are not mentioned that honestly show the financial impact.

Some of the categories include, but not unlimited to:

- 1) cost of daily business, (city office operations)
- 2) added costs due to Safe and Sane Fire Works (SSFW) event,
- 3) the costs of illegal Fireworks (FW).
- 4) cost for just the holiday (added public safety, overtime, the same as any other city)

At the end of the day, there is a cost of everyday business, 4-July event or not. The city offices still need to be open. You already charge a processing fee for the application. These costs should not be passed to the event.

There is a cost for the 4-July day, even if there were no SSFW, there would still need to be extra public service personnel just for what happens on this holiday. This is a standard operating cost associated with holiday operations.

Then there is a cost of illegal fireworks that you still have, whether you allow or ban the sale of SSFW. It is my understanding that these costs will still be there if SSFW were banned. So at this point, it seems the city is charging the Fireworks Group for services not directly related to the sale of SSFW. You keep mentioning that not all charges are accurately reflected.

On your email, (Paragraph 4), you state "Keep in mind there is no proposal to ban the sale of safe and sane fireworks for the 2022 season." Please help me understand the statement and the documentation provided by the City Council. They seem to not agree in focus or theme.

May I point out to you:

### Hello,

My name is Kristian Menotti and I am the mother of a child who attends James Logan High School. My son has been involved with the Forensics Program/Speech and Debate program at James Logan for the past 4 years. He has represented James Logan at Speech and Debate tournaments all over the country including the tournament of champions (the most prestigious event in High School debate in the country). The speech and debate program at James Logan has been instrumental in molding my son into the bright, well spoken, confident and critical thinking young man he is today. Unlike a lot of other forensics/speech and debate programs in our area our program at James Logan depends on fundraisers to support the program financially. The program is dependent on several fundraising ventures each year including a fireworks booth in July that alone raises \$63,000 a year for our program. Without this event our program to students. This would be shameful as our program is one of the most gifted, awarded and nationally recognized in the nation!

I am writing you to express my opposition to banning safe and sane fireworks. State approved fireworks are not problematic in our city. Every year the people in my neighborhood purchase them and we enjoy them as a community. It is honestly the only time during the entire year we all gather on our street and share stories, fellowship and fun. In a world where we are more disconnected than ever the fun and good times of the 4th brings our neighborhood together and we feel like a community. Honestly, I feel like my gas grill could be more of a fire hazard than the safe and sane fireworks we use! The issue and hazard appear to be more linked to the illegal fireworks that people are utilizing. Banning safe and sane fireworks does not appear to have a direct impact on illegal fireworks. An example of this is with the cities of Oakland and Fremont. Both cities have bans on all fireworks yet people continue to utilize illegal fireworks. In fact, the sky over Oakland on July 4th can rival professional fireworks shows! Under the current city ordinance, State-Approved Fireworks may only be used from 8:00 pm to 11:00 pm on the 4th of July. This means there are 3 hours out of the 8760 hours that make up each year that these fireworks are legal to use in Union City. If banning them would solve the city's illegal fireworks problem why does the city have illegal fireworks being used to the balance of the 8, 757 hours each year? Finally reducing the number of hours for the legal use of safe and sane fireworks from 3 hours to 2 hours on the 4th of July does not appear to be impactful. It would compact the use of almost \$400,000 of state approved fireworks into 2/3 of the current time. If any change is made to the hours of use, it should be to expand the hours and/or days of use not compact use into a shorter time period.

The banning of safe and sane fireworks will not impact the use of illegal fireworks. The impact will be on all of the programs in Union City, including the James Logan Forensics/Speech and Debate program that depend on fundraising through the fireworks booths. Please consider alternative solutions including increase in police presence, tip lines, social media efforts, etc to assist with the control of illegal fireworks use. Please do not punish the innocent people who enjoy safe and sane fireworks as well as the many organizations in our community that depend on the fundraising that the sale of safe and sane fireworks provides.

The Union City-City Council May Vote to Ban the Sale and Use of State Fire Marshal-Approved Fireworks.

The James Logan Forensics Team is in urgent need of your immediate support and help! The Union City-City Council is considering banning the sale and use of State Fire Marshal-Approved, Safe and Sane Fireworks. Each year the sale of these fireworks raises almost \$400,000 for Union City nonprofits, providing over \$225,000 in funding for eight different programs at James Logan High School along with over \$173,000 for ten other youth and non-profit programs in Union City. For our program alone, a ban on this fundraiser would mean a loss of over \$63,000 each year and would decimate our program!

Mayor Carol Dutra-Vernaci has instructed the City Manager to hire a professional polling firm to call, text and email registered voters in Union City beginning this coming Monday to purportedly gauge the community's support for her effort to ban the sale and use of the State-Approved Fireworks we sell each year as our primary fundraiser. The city is also conducting a public webinar on Thursday, September 23, 2021, where city staff will make presentations, but we, along with other Union City nonprofits, are not being allowed to contribute or participate in the information that will be broadcast. Currently, city staff is working on proposed ordinance amendment options that will do the following:

- Reduce the number of hours for legal use of State-Approved Fireworks from its current 3 hours (8:00 PM to 11:00 pm) on the 4th of July to 2 hours (8:00 pm to 10:00 pm).

- Make the use of illegal fireworks a misdemeanor, increase the fine to \$1,000, enact a Fireworks Social Host ordinance to permit the city to cite property owners for use of illegal fireworks on their property. Remove the word "infraction" from the city's existing fireworks ordinance to allow the issuance of \$1,000 administrative citations for use of illegal fireworks.

- These proposed changes in the city's fireworks ordinance will be brought before the City Council for discussion and adoption in a matter of weeks. While we support Options #2 and #3 above, Option #1 defies common sense. It would compact the use of the State-Approved Fireworks we sell from 3 hours to 2 hours for no logical reason.

### HERE ARE THE FACTS!

- State-Approved Fireworks are not the problem in Union City...Illegal Fireworks are the problem! If State-Approved Fireworks were a problem in Union City, don't you think you would be given local statistics of fires and injuries?

- Banning the sale and use of State-Approved Fireworks will not lead to less illegal fireworks, it will lead to significantly more illegal fireworks. Just look at our neighboring cities of Oakland and Fremont where all fireworks are illegal.

- The reality in Union City is that under the current city ordinance, State-Approved Fireworks may only be used from 8:00 pm to 11:00 pm on the 4th of July each year. That means there are just 3 hours out of the 8760 hours that make up each year that these fireworks are legal to use in Union City. Dear Union City Leaders:

I'm happy that you're having a community discussion regarding fireworks but unfortunately, I'm unable to participate so I'm sending you my comments.

The use of illegal fireworks in Union City over the past few years around Independence Day and New Year's has escalated and nothing appears to be done to diminish or eliminate them. I live near Arroyo Park and have noticed that the fireworks are regularly set off in the same area (between my neighborhood and Civic Center).

Increasing the fine for using illegal fireworks won't decrease the use because only a small number of citations are given out compared to the number of illegal fireworks. The supply of illegal fireworks needs to be cutoff. I'd hope that our city would join with others to make a real impact in confiscating illegal fireworks. I was heartened to see some agencies on the Peninsula doing just that.

Please make sure that the community discussion this week isn't just focused on July 4 because the problem is much bigger than that. In late May, I started noting when illegal fireworks went off within a mile or two of my home (see data below).

I've always been a champion for our city and have supported and voted for every measure it placed on the ballot. This year's experience with daily explosions has had a strong impact on quality of life in the city. My dog suffered every time there was a boom.

I look forward to seeing how you'll decrease the use of illegal fireworks. The city may be compassionate but it's not as nice a place to live anymore.

Hello Anna, per the city meeting on 2021-09-23 at 6PM regarding fireworks here is my written public comment:

I am a fifth generation bay area native and have been a Union City resident for six years in Seven Hills, east of Mission Boulevard, where all types of fireworks are illegal. Every year there are fireworks going off in the apartment complex and condo parking lots, in the streets, and in backyards in my neighborhood where there should be none. Before the pandemic these would be mostly isolated to the weeks around the fourth of July with a big increase on the fourth including non residents coming in from elsewhere and setting fireworks off at the top of Appian way. Since May/June 2020 there have been fireworks going off every weekend and sometimes every weeknight. The quantity of illegal fireworks is so extreme on the fourth that every year I have to choose between sedating my dog or packing up and leaving town with the hope that no one burns my house down while I am away. I have stood by with a fire extinguisher and hose at the ready while my neighbors up the hill managed to burn down a fence, while someone set fire to the empty lot at the top of Appian way, and while the hill above the seven hills park (next to my house) was set ablaze eliciting a multi engine fire response for ACFD. I have even chased teenagers out of the open space along the back of Riviera Drive who were setting off illegal roman candle fireworks into the hills ~ the police had no units to spare to make an arrest and had these children started a fire it would have been difficult to contain given the terrain. When the fourth of July is over the leftovers and debris we find in the streets and parks are from both illegal and safe and sane fireworks despite none of them being allowed east of Mission Blvd. Given the flagrant violation of the law, frequent misuse of safe and sane fireworks, and the persistent droughts ravaging the west coast there is no longer a case for any amateur fireworks simply put conditions are too dry, fuels too numerous, and resources spread too thin.

Union City needs to take urgent action to:

1.) Stop the sale of all fireworks in the city.

2.) Increase the penalty for illegal fireworks possession and use to at least \$1,000

The use of illegal fireworks is so rampant and the city so overwhelmed that the sale of all fireworks must be halted so that a clear message is sent and so that the police can issue meaningful citations under a zero tolerance policy.

Detractors to the ban of fireworks often cite the loss of funds to schools, youth sports, and community organizations; the rest of Alameda County and the bay area somehow manage to find other funding sources year after year. I challenge them to find and offer literally any other fundraising source. This debate is not about funding for programs, it is about safety and quality of life.

To Whom It May Concern,

Thank you for welcoming community feedback on the discussion of fireworks.

According to the National Safety Council (NSC), in 2017, over 12,000 people were injured by fireworks badly enough to require medical attention. Of those injured, 50% were children and young adults under the age of 20. Furthermore, fireworks start an average of 18,500 fires each year. Fireworks can quickly ignite clothing and dry brush, causing serious risk to personal safety and increased potential for wildfires.

While the Union City police department has the best of intentions, it is virtually impossible to catch someone in the act of igniting an illegal firework or "safe and sane" firework during an unapproved time. Repeated loud explosions that occur weeks before and after the 4<sup>th</sup> of July holiday are detrimental to some members of the community, including those with PTSD, babies and pets. According to Union City leaders, in 2021, there were 169 reports of illegal fireworks use. Only 26 of these resulted in citations. This means less than 16% of reported cases were fined, not to mention the **dozens** of incidents that were not reported. Additionally, there were many fires causing damage to property. Frankly, it is not the best use of police and fire staff to manage the ever-increasing usage of fireworks.

Additionally, some community members leave the remains of their fireworks celebrations in the streets, causing unsightly and dangerous litter.

While many of us have long enjoyed the experience of fireworks celebrating the holiday, we would argue that the risk is no longer worth the danger to the community. Many Bay Area cities have instituted professional fireworks shows so that the community members are able to enjoy a fireworks display while remaining safe and localizing the noise disturbance to a few hours.

We urge city officials to consider limiting the use of fireworks in Union City including the elimination of "safe and sane" fireworks to increase public safety, decrease fire hazard and reduce the cost of clean-up.
