## 7. CITY MANAGER REPORTS

### 7.b. Adopt a Resolution Approving an Amendment to the Classification Plan and Amending the Compensation and Benefit Plan for Unrepresented Employees to Create the Position of Information Technology Director and Approving an Amendment to the City's Compensation Plan and Salary Schedule in Conformance with California Code of Regulations, Title 2, Section 570.5

City Manager Malloy presented the staff report detailing the need for the position description, responsibilities, and the compensation plan and benefits. City Manager Malloy responded to questions from Council. Councilmembers provided comment.

It was moved by Vice Mayor Patiño and seconded by Councilmember Duncan to adopt **Resolution No. 5898-22** Approving an Amendment to the Classification Plan and Amending the Compensation and Benefit Plan for Unrepresented Employees to Create the Position of Information Technology Director and Approving an Amendment to the City's Compensation Plan and Salary Schedule in Conformance with California Code of Regulations, Title 2, Section 570.5. The motion was carried by unanimous roll call vote.

City Attorney Kokotaylo presented the staff report and responded to questions from Council. Councilmembers provided comment.

It was moved by Councilmember Singh and seconded by Councilmember Gascos to waive full reading and introduce by title only an Ordinance of the City Council of the City of Union City amending Section 2.26.020 of Chapter 2.26, "Arts & Culture Commission," of the Union City Municipal Code. The motion was carried by unanimous roll call vote.

- 7.d. Adopt a Resolution of the City Council of the City of Union City Approving an Employment Agreement with Jared Rinetti as Police Chief and Approving an Amendment to the City's Salary Schedule in Conformance with California Code of Regulations, Title 2, Section 570.5

City Attorney Kokotaylo presented the staff report. There were no questions or comments from Council.

The motion was carried by unanimous roll call vote.

Public Hearing to Receive Community Input Regarding District Boundaries for District-Based Elections Pursuant to Elections Code Section 21607.1 (3rd Hearing) and Introduce an Ordinance of the City Council of the City of Union City Adopting the Final Map of District Boundaries for District-Based Elections of Councilmembers in Accordance with the Redistricting Process for the Federal Decennial Census, and Amending Union City Municipal Code Section 2.04.510 - Start Time at 7:30 p.m.

City Attorney Kokotaylo provided a summary of the redistricting process completed thus far and introduced consultant Robert McEntire of National Demographics Corporation.

Mr. McEntire reviewed the draft district maps and demographic data considered thus far and presented a new draft map with demographic data, Map 201b. Mr. McEntire responded to questions from Council.

Mayor Dutra-Vernaci opened the public hearing.

Public comment was provided by Jugraj Singh.

Councilmembers provided comment. Following discussion, Council consensus was to introduce Draft Map 201 for adoption.

It was moved by Councilmember Duncan and seconded by Councilmember Gacoscos to introduce an Ordinance Adopting Map 201 as the Final Map of District Boundaries for District-Based Elections of Councilmembers in Accordance with the Redistricting Process for the Federal Decennial Census, and Amending Union City Municipal Code Section 2.04.510. The motion was carried by unanimous roll call vote.
