Honoring Tommie Lindsey for his contributions to education both inside and outside the classroom as a Teacher, Mentor, and Role Model. July 25, 2017

Whereas, Tommie Lindsey graduated from the University of San Francisco with a degree in Communication Arts and Social Science as the first African American valedictorian; and,

Whereas, Tommie first taught public speaking at Alameda County Juvenile Hall in 1976; it was there that he decided he wanted to reach these students before they got to Juvenile Hall; and,

Whereas, Tommie went on to create an all African American male Life Skills class at James Logan High School, a program recognized by Phi Delta Kappa's Academic Journal for the University of Northern Iowa in February 2012 for providing an environment that promotes inclusion, builds security, enhances meaning, and engenders competence; and,

Whereas, this publication has been an asset for educators across the country, helping to replicate **Tommie's** class model in their own districts; and,

Whereas, Tommie's life skills class formed the James Logan High Forensics team in 1984, and under Tommie's leadership his teams have won several national and state titles, regularly outranking the country's elite schools; and,

Whereas, Tommie has co-authored the book "It Doesn't Take A Genius" that encapsulates the life experiences and growth of many of his top former student competitors in both their academic and professional careers beyond high school; and,

Whereas, Tommie and the James Logan High School Forensics program were the feature of a 2001 documentary entitled "Accidental Hero: Room 408" that won critical acclaim at the Ashland International Film Festival, the CineQuest Film Festival, and the Hot Springs Documentary Film Institute, which caught the attention of Oprah Winfrey who awarded Tommie with her Angel Award; and,

Whereas, for over 20 years former James Logan High School Forensics team competitors have gone on to coach at both the high school and collegiate programs since their graduation, which serves as a testament to the program's commitment to students who are at risk or who come from troubled backgrounds. This is reflective of the tremendous legacy and honor of **Tommie Lindsey** and the power of his words as he reminds us to "Use your voices as your drums until social justice becomes the rhythm of the land;" and,

Now, therefore, this Board of Supervisors, County of Alameda, State of California, does hereby commend **Tommie Lindsey** for his dedication and contribution to education. We are grateful to **Tommie** for providing us with his lasting legacy.

6. PUBLIC HEARINGS

6.a. Public Hearing for Renewal of Landscape & Lighting District No.3

City Engineer Thomas Ruark presented the staff report, noting that the assessment rate has not been changed for 20 years (same level since 1996-97 fiscal year). Services provided include street lighting, street traffic signals, street landscaping, urban forestry, and a portion of parks maintenance.

Noting the \$1.5 million expense to the budget, Council requested staff conduct outreach to the public on the potential of indexing the assessment to the rate of inflation. Council also expressed a concern about getting to the point where service cannot be provided with the same reliability if the assessment remains the same.

City Manager Acosta stated staff will conduct social media outreach and come back with findings in approximately 60-90 days.

Vice Mayor Gacoscos opened the public hearing and called for public comment.

Dave Bhatia stated the City should look at how energy can be further conserved before considering an increase.

Being no further comment, Vice Mayor Gacoscos closed the public hearing.

City Manager Acosta stated the City has a conservation plan in place and solar panels will be installed on City facilities where it is architecturally allowable in the next 30-60 days.

Economic and Community Development Director Joan Malloy introduced Rob Flaner of Tetra Tech and Hazard Mitigation Plan Technical Lead.

SUBJECT: SECOND READING AND ADOPTION OF AN ORDINANCE OF THE CITY

OF UNION CITY REAUTHORIZING THE PUBLIC, EDUCATIONAL, AND GOVERNMENT (PEG) FEE ON STATE CABLE FRANCHISEES OPERATING WITHIN THE CITY AND AMENDING SECTION 5.38.040 OF

THE UNION CITY MUNICIPAL CODE

On July 11, 2017, the City Council introduced the attached ordinance reauthorizing the City's PEG fee and amending Section 5.38.040 of the Union City Municipal Code.

State law requires that cities periodically reauthorize their public, educational, and governmental ("PEG") fee on state cable franchisees operating within their jurisdictions. This is required each time a state cable franchise expires. The proposed ordinance would reauthorize the City of Union City's PEG fee and amend the Municipal Code to add automatic reauthorization language.

Staff recommends that the City Council conduct the second reading and adopt the attached ordinance.

BACKGROUND

Under the Digital Infrastructure Video and Competition Act of 2006 ("DIVCA"), the City's existing franchise agreement with the incumbent local cable operator remains in effect until its expiration on April 21, 2020. In addition, statewide franchisees, like AT&T, now also provide cable services in the City. Under the City's Municipal Code, the City's incumbent cable operator and all state franchisees operating in the City are required to divide responsibility for collecting the PEG fees required in the local franchise agreement until April 21, 2020.

After that date, UCMC Section 5.38.040(C) requires that all state franchise holders collect PEG fees in the amount of one percent (1%) of gross revenues. However, DIVCA requires that that local PEG fee ordinances, like Section 5.38.040(C) must be reauthorized each time a state franchise expires.

DISCUSSION

AT&T California operates within the City under a statewide cable services franchise that expires on March 30, 2017. To ensure that AT&T will be required to collect and remit the PEG fee between April 22, 2020 and the expiration of its next franchise (in 2027), staff recommends that the City Council reauthorize Section 5.38.040(C) by adopting the attached ordinance.

In addition to reauthorizing the PEG fee with regard to AT&T, the attached ordinance would add a provision to the Municipal Code to provide that, upon the expiration of any state franchise, the City's PEG fee is automatically reauthorized unless the state franchise holder has given the City Council and City manager 60-days' written notice prior to the expiration of its state franchise that the City's PEG fee will expire.

FISCAL IMPACT

Adoption of the proposed ordinance will ensure collection and remission of one percent (1%) of AT&T's gross revenues on and after April 22, 2020. Proceeds of PEG fees may only be used for the support of PEG channel facilities (such as the recent audio-visual upgrade of the City Council Chambers).

RECOMMENDATION

Waive reading the full text of the attached ordinance, conduct the second reading of the title of the attached ordinance, and adopt the attached ordinance reauthorizing the City's PEG fee and amending Section 5.38.040 of the Union City Municipal Code.

AN ORDINANCE OF THE CITY OF UNION CITY REAUTHORIZING THE PUBLIC, EDUCATIONAL, AND GOVERNMENT (PEG) FEE ON STATE CABLE FRANCHISEES OPERATING WITHIN THE CITY AND AMENDING SECTION 5.38.040 OF THE UNION CITY MUNICIPAL CODE

WHEREAS, the City Council previously adopted Section 5.38.040(C) of the Union City Municipal Code ("UCMC"), which imposes a public, educational, and governmental ("PEG") fee on state cable franchisees operating within the City as authorized in the Digital Infrastructure and Video Competition Act of 2006; and

WHEREAS, Section 5870(n) of the California Public Utilities Code states that a PEG fee ordinance must be reauthorized upon expiration of an applicable state franchise; and

WHEREAS, AT&T California ("AT&T") operates within the City under a state franchise that expired on March 30, 2017; and

WHEREAS, the City Council wishes to adopt an ordinance expressly declaring that the City's PEG fee is reauthorized and amending UCMC Section 5.38.040.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF UNION CITY DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. PEG Fee Reauthorization.

The City's PEG channel facilities fee authorized in subsection (C) of Section 5.38.040 of the Union City Municipal Code is hereby reauthorized to the extent required by Section 5870(n) of the California Public Utilities Code.

Section 2. Addition of Subsection (F) to Section 5.38.040 of the Union City Municipal Code.

UCMC Section 5.38.040 shall be amended to add the following subsection (F) to read as follows:

F. Notwithstanding subdivision (n) of Public Utilities Code Section 5870, upon the expiration of any state franchise, without any action of the City Council, subsection (C) of this section shall be deemed to have been automatically reauthorized unless the state franchise holder has given the City Council and City Manager written notice sixty (60) days prior to the expiration of its state franchise that this section will expire pursuant to the terms of subdivision (n) of Public Utilities Code Section 5870.

The remaining provisions of Section 5.38.040 shall remain unchanged and in full force and effect.

Section 3. Severability.

The provisions of this Ordinance are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions,

clauses, sentences, sections, words or parts thereof of the Ordinance or their applicability to other persons or circumstances.

Section 4. Effective Date.

This Ordinance shall take effect and be in force thirty (30) days following its adoption.

Section 5. Publication or Posting.

The City Clerk of the City of Union City shall cause this Ordinance to be published or posted as required in Section 36933 of the Government Code of the State of California.

AGAINST CERTAIN PROPERTIES LOCATED IN THE CITY OF UNION CITY FOR DELINQUENT SOLID WASTE, RECYCLING AND ORGANIC WASTE SERVICE CHARGES; ADOPT A RESOLUTION APPROVING THE FILING OF ASSESSIBLE LIENS AGAINST CERTAIN PROPERTIES LOCATED IN THE CITY OF UNION CITY FOR DELINQUENT SOLID WASTE, RECYCLING AND ORGANIC WASTE SERVICE CHARGES AND DIRECTING STAFF TO FORWARD SUCH LIENS TO THE ALAMEDA COUNTY TAX ASSESSOR AND AUDITOR-CONTROLLER FOR PLACEMENT ON THE FISCAL YEAR 2017-18 SECURED PROPERTY TAX

ROLL

Staff recommends that:

- 1. A Public Hearing be conducted by the City Council to hear the appeals (if any) from residential property owners who remain delinquent in the payment of related fees and service charges for the collection of Municipal Solid Waste (MSW), Organic Waste and Recycling.
- 2. Adopt a resolution approving the filing of assessable liens against such properties and forwarding such liens to the Alameda County Assessor for placement on the Fiscal Year 2017-18 secured property tax roll and the Alameda County Clerk-Recorder's Office for official recordation. Staff recommends adoption of the proposed resolution.

BACKGROUND

Regular weekly collection of refuse, organics and recyclables is mandatory in Union City. Homeowners pay for these services through Special Assessments on the annual property tax statement mailed to each parcel by the County Tax Collector. The City of Union City is one of the few cities that places such service charges on the Secured Property Tax Roll, instead of relying on its collection contractor to bill each parcel and collect fees in the traditional manner.

DISCUSSION

In 2015 an audit by NBS, the City's tax roll consultant, identified thirty (30) properties that for unknown reasons were not assessed through the tax roll for curbside collection services. Staff corrected the situation beginning with Fiscal Year 2015-16; special assessments for refuse, recycling and storm water now appear on the annual property tax statements of the parcels previously not assessed.

Pursuant Section 7.04 of the Union City Municipal Code, "The solid waste and recycling franchisees shall be entitled to payment from the property owner for any services rendered." In July 2016, Republic Services (Republic) sent a letter to the thirty property owners requesting payment for collection services in tax years 2012-13, 2013-14 and 2014-15. Single family property owners were billed \$1,468.48 and parcelized multifamily homeowners were assessed \$1,115 for three years of service, the same total amounts paid by Union City residential property owners correctly assessed through the secured tax roll. Twenty (20) of the property owners contacted by Republic made arrangements with the hauler to pay for past service. Ten (10) of the properties did not respond to multiple requests for payment and were recently referred to the City by Republic Services.

The assessable lien process outlined in the Municipal Code addresses the question of Solid Waste Collection and Disposal, Organic Waste Collection and Composting and Recycling Collection and processing by:

- Establishing a procedure and notice for delinquent collection charges;
- Establishing an Administrative Hearing to hear any protests regarding delinquent charges for services;
- Creating a reporting mechanism to the City Council on delinquent collections;
- Creating a Notice of Public Hearing, Council review and approval of property tax liens; and
- Providing for notification to the County Assessor and Auditor Controller regarding assessment of property liens.

On April 28, 2017, registered letters were sent to all 10 property owners advising each owner that the delinquent service charges were due and payable immediately; a payment response form was also included. The property owners were also advised of the date, time and place for an Administrative Appeal Hearing (June 6, 2017 at 1pm in City Hall) to protest the charges.

Four (4) property owners paid their delinquent charges before the Administrative Appeal Hearing. Two (2) of the properties were sold in 2016, after the delinquent charges were incurred. One (1) property owner attended the administrative hearing but provided incomplete information confirming payment for services rendered. Letters to three (3) other parcels have failed to generate a response to the request for payment for collection services.

A second registered letter was sent to the remaining four (4) delinquent property owners on July 11, 2017, advising of the date, time and place of the Public Hearing before the City Council on July 25, 2017 at 7 pm. The second notice again provided an opportunity to pay the delinquency or present evidence that the proposed assessment and lien is incorrect, before a lien, administrative fees, and penalties would be levied on their parcel. As of the preparation date of this staff report (July 18), no property owner has advised staff of their intent to appeal their delinquency at the City Council public hearing.

City Council Process

If necessary, and in order to minimize use of the City Council's time during the public hearing, staff proposes that:

• the Mayor open the public hearing,

- the City Council appoint the following Hearing Officers to hear any appeals filed by property owners
 - Mark Carlson, Director of Administrative Services
 - Roberto Muñoz, Solid Waste & Recycling Coordinator
 - o Jennifer Cutter, Recycling Programs Coordinator

Multiple Hearing Officers are recommended so that several appeals can be handled simultaneously in hearing rooms outside the Council Chambers.

- The Mayor continues the public hearing until the appeals (if any) have been heard by the Hearing Officer(s),
- The Hearing Officers hear and consider information provided by the appellant(s), and make a preliminary determination on the appeal,
- All parties return to the Council Chambers and the Mayor re-opens the public hearing,
- The City Council hears the report of the Hearing Officers and testimony from each appellant, gives the information due consideration, and makes a final determination on each appeal, and
- The City Council then adopts the proposed resolution to implement its findings and determinations.

It should also be noted that the City has until early August to prepare and submit amendments to the FY 2017-18 Secured Property Tax Roll to the County Tax Assessor and the County Auditor-Controller.

Privacy rules require the City to keep the identification of the property owners confidential until such time that the lien resolution is transmitted to the recorder / assessor's office. Council will be given a detailed copy of the parcel list after submittal of liens to the Alameda County Assessor's Office. This list will remove any property owner that is recommended by Council, or that pays their delinquent assessments by the end of the Public Hearing.

FISCAL IMPACT

A total of \$33,477 has been collected to date by Republic Services and the City from property owners who were not originally assessed for collections services between 2012 and 2015. Four (4) properties remain delinquent in payment for past services rendered. With the addition of a \$50 Service Fee per parcel for staff time and mailing costs required to process the proposed liens, the maximum amount to be assessed via property tax liens at this evening's City Council meeting is \$1,518.48, less any adjustments made by the City Council or due to payments.

RECOMMENDATION

It is recommended that the City Council consider appeals from property owners who remain delinquent in the payment of fees and service charges for the collection of Municipal Solid Waste (MSW), Organic Waste and Recycling and after due consideration and findings, adopt a resolution directing staff regarding the submittal of assessable liens with Alameda County Assessor and Auditor-Controller for inclusion on the 2017-18 Secured Property Tax Roll and Alameda County-Clerk Recorder for official recordation.

A RESOLUTION APPROVING THE FILING OF ASSESSABLE LIENS AGAINST CERTAIN PROPERTIES LOCATED IN THE CITY OF UNION CITY FOR DELINQUENT SOLID WASTE, RECYCLING AND ORGANIC WASTE SERVICE CHARGES AND DIRECTING STAFF TO FORWARD SUCH LIENS TO THE ALAMEDA COUNTY TAX ASSESSOR AND AUDITOR-CONTROLLER FOR PLACEMENT ON THE FISCAL YEAR 2017-18 SECURED PROPERTY TAX ROLL

WHEREAS, it has been the practice of the City of Union City for many years to place Single Family Residential ("SFR") and Parcelized Multi-Family ("MFR") service charges for Municipal Solid Waste ("MSW"), Organic Waste and Recycling collection on the Secured Property Tax Roll to maximize compliance with the City's mandatory collection codes and ensure timely payment of service charges; and

WHEREAS, Section 7.04 of the Union City Municipal outlines the process for the placement of assessable liens against residential properties located within the City of Union City whose owners had failed to pay service charges for Municipal Solid Waste ("MSW"), Organic Waste and Recycling collection as required by law; and

WHEREAS, a review of residential parcels located in the City of Union City revealed that thirty (30) parcels located in the City had received collection services, but had not been assessed the appropriate service charges for such services; and

WHEREAS, ten (10) of the parcels did not respond to requests for payment for past services by Republic Services and were therefore referred to the City for collection; and

WHEREAS, in accordance with the Municipal Code appropriate notices were sent to the owners of the the parcels with delinquent MSW, Organic Waste and Recycling collection service charges in which each property owner has been given the opportunity to pay the delinquent assessments, or to appeal the proposed placement of assessable liens against their properties for said delinquent assessments plus applicable administrative service fees; and

WHEREAS, an administrative hearing to consider appeals of said delinquent assessments and assessable liens was duly noticed and scheduled for June 6, 2017 at 1:00 p.m. in City Hall, 34009 Alvarado-Niles Road, Union City; and

WHEREAS, four property owners have since paid past due amounts and two properties were sold in 2016, four parcels remain with delinquent amounts; and

WHEREAS, additional notice was given to all owners of properties with delinquent MSW, Organic waste and Recycling collection service charges and advised of the date time and place for a public hearing before the City Council on July 25, 2017 at 7:00 p.m. in the City Council Chambers, 34009 Alvarado-Niles Road, Union City to consider appeals of the proposed placement of assessable liens against their properties in accordance with the Municipal Code; and

WHEREAS, the City Council appointed Hearing Officers to conduct investigations into each appeal filed by Appellants at said public hearing, and has considered the information provided by the Hearing Officers and Appellants concerning the delinquent service charges for MSW, Organic Waste and Recycling collection and the proposed assessable liens to recover said service charges plus administrative service fees; and

WHEREAS, the City Council hereby finds and determines that each property owner listed in Exhibit A, attached hereto and incorporated herein by reference, has failed to pay delinquent service charges for MSW, Organic Waste and Recycling collection services provided to their properties, and that the placement of assessable liens against their properties is therefore in the public interest.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Union City does hereby order and direct the City Manager to prepare and transmit all necessary documents required to place assessable liens on the secured property tax roll for the properties listed in Exhibit A, to the Alameda County tax Assessor and Auditor-Controller for Fiscal (tax) Year 2017-18.
